2008-2009 MILLION MILE CHALLENGE GUIDELINES

- 1) CHALLENGE RUNS FROM NOON, JULY 12, 2008 TO NOON, JULY 12, 2009.
- 2) PARTICIPANTS **MUST** BE A **CURRENT** NATIONAL H.O.G. MEMBER AND **CURRENT** FORT WORTH TEXAS H.O.G. MEMBER. RIDERS AND PASSENGERS ARE ELIGIBLE TO EARN MILES.
- 3) ONLY THE OFFICIAL CHAPTER MILEAGE FORM CAN BE USED FOR REGISTERING AND REPORTING MILEAGE. FORMS AVAILABLE THROUGH ANY FORT WORTH H.O.G. PRIMARY OFFICER.
- 4) MILEAGE CAN ONLY BE DOCUMENTED BY A DESIGNATED OFFICER OF THE FORT WORTH H.O.G. CHAPTER. (PRIMARY OFFICER OR HEAD ROAD CAPTAIN)
- 5) REGISTRATION AND MILEAGE VERIFICATION CAN BE DONE ON ANY FORT WORTH H.O.G. RIDE, EVENT OR CHAPTER FUNCTION. MILEAGE **CANNOT** BE VERIFIED AT FORT WORTH HARLEY DAVIDSON.
- 6) ONLY MILEAGE LOGGED ON A REGISTERED HARLEY-DAVIDSON MOTORCYCLE WILL BE ELIGIBLE FOR THIS PROGRAM.
- 7) YOU CAN REGISTER AS MANY HARLEY-DAVIDSON MOTORCYCLES AS YOU WISH. EACH MOTORCYCLE MUST BE REGISTERED IN THE CHALLENGE BEFORE MILEAGE WILL BE AWARDED TO THAT MOTORCYCLE.
- 8) IN THE EVENT YOUR NATIONAL H.O.G. MEMBERSHIP OR FORT WORTH H.O.G. MEMBERSHIP EXPIRES DURING THE CHALLENGE, YOUR MILEAGE WILL BE SUSPENDED AT THE LAST REPORTED READING UNTIL MEMBERSHIP IS RENEWED. A NEW MILEAGE READING WILL BE TAKEN UPON RENEWAL AND YOUR MILEAGE WILL CONTINUE COUNTING. IF MEMBERSHIP IS NOT RENEWED IN 30 CALENDAR DAYS OF EXPIRATION, ALL MILES PREVIOUSLY ACCUMULATED WILL BE VOIDED AND YOU WILL BE REQUIRED TO RE-ENTER THE CHALLENGE WITH ZERO MILES.
- 9) ALL DECISIONS CONCERNING THE CHALLENGE WILL BE MADE BY THE FORT WORTH H.O.G. CHAPTER DIRECTOR AND THE SPONSORING DEALER, FORT WORTH HARLEY-DAVIDSON. ALL DECISIONS WILL BE FINAL.
- 10) ALL REGISTRATION FORMS AND REPORTING FORMS WILL BE KEPT WITH CHAPTER RECORDS FOR VERIFICATION ON JULY 12, 2009 AT 12:00 PM.
